The Right of Association in Sweden and "the Swedish model"

- You have the right of freely join a trade union of your choice.
- It is a violation against the freedom of association if anyone tries to prevent you from joining.
- The level of trade unionen membership in Sweden is about 70% and membership is often encouraged by employers.



The Right of Association in Sweden and "the Swedish model"

The Swedish Model In Sweden, employers and trade union organisations work together to agree on terms, conditions and pay levels. Having large numbers of members is a precondition for both parties.

Income protection insurance

- Tops up unemployment (a-kassa) benefits.
- You can insure an income of up to SEK 60 000/month.
- Paid for 150 days, approx. 7 months.
- Even more peace of mind: Voluntary top-up insurance for extra days and incomes up to SEK 150,000/month.
- Short qualifying period 12 months.



Legal aid

- We know what your rights are and are experts on Swedish business and industry.
- Quick and professional support and we will help you to negotiate if problems arise at work.
- Unionen can uphold your rights by protecting your interests during reorganisation and redundancy, for example.



- Assistance with negotiations during disputes.

Collective agreement

- Terms and conditions adapted to your industry and rules exceeding those set out in legislation.
- Pay rises, overtime payments, parental pay and workplace pensions etc.

Influence in the workplace
